The envelope should be addressed to the Principal, P S No.2, Tin Shing Court, Area 3, Tin Shui Wai, N.T. and arrive not later than 12:00 noon on **12 June 2026**. Late tenders will not be accepted. Suppliers should not identify the name of companies on the tender cover.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or “extreme conditions after super typhoons” announced by the Governments is/are in force, at any time between 9:00 a.m. and 12:00 noon (Hong Kong time) on Friday, 12 June 2026, the latest date and time before which tenders are to be delivered to school will be extended to 12:00 noon (Hong Kong time) on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the “extreme conditions after super typhoons” announced by the Government has/have ceased to be in force.

Your tender will remain open for 90 days from the “Closing Date”, and you may consider your tender to be unsuccessful if no order is placed with you within these 90 days. You are requested to note that unless Part II of the tender form is completed, the tender will not be considered.
